STATEMENT OF ACTIVITIES

July 1, 2022 through April 30, 2023

YEAR TO DATE ADMINISTRATIVE EXPENSE DETAIL

Administrative Expenses for Fiscal Year 2023 totaled \$5,017896.29 on April 30. This total represents 79.99% of the Council's administrative budget utilized. Total spending for this time period is budgeted to be 83%. Individual line-item budgets and expenses are monitored monthly to ensure funds are utilized appropriately and budget revisions are requested from funding agencies as needed. The cumulative Indirect Cost rate for this period is 48%. Projected Indirect Costs for Fiscal Year 2023 are 50.69%.

AGING AND DISABILITY PROGRAMS SERVICES & FUNDING REPORT

The Aging and Disability Division worked with various service providers and helped administer a multitude of direct service programs to eligible residents of our eight-county region. Between July 1 and April 30, more than \$9 million in direct service dollars were utilized to provide the units of service listed in the report. BHRC continues to support our provider network to evaluate the needs of the communities and serve area seniors in the best way possible.



CURRENT INITIATIVE/ NEWS

State Budget Updates: Department of Aging

Healthy Aging Grants | \$40 million in ARPA appropriated in 2024 but changes language from being distributed to "local partners" to county commissioners. These funds will be distributed by formula to each of Ohio's 88 counties. The amount awarded will be a \$100,000 base with additional funds based on non-Medicaid eligible population census. Funds must be used for projects serving older adults and must have measurable outcomes

Senior Community Services | Reduction of Senior Community services appropriation from \$ 12,832,194 (2024) \$ 12,832,323 (2025) in Governor's budget to \$11 million per year in House substitute bill.

The Ohio Association of Area Agencies are requesting a return to the Governor's original amount requested in the Executive Budget.

State Budget Updates: Department of Medicaid

Assisted Living | Retains 48% increase and removal of tiers with memory care add on,

Rates and Adjustments | Requires that in FY 2024 and FY 2025, ODM include in each nursing facility's base rate only 40% of the sum of the increase in its rate for the direct care costs and its rate for ancillary and support costs resulting from the nursing facility rebasing.

Increases the rate of rebasing beginning in FY 2024 to at least every two years, from at least every five years.

Extends quality incentive payments indefinitely, rather than ending the payments after FY 2023.

Modifies existing law procedures under which an individual or entity that assumes operation of a nursing home must disclose certain information to the ODH Director, to instead require the individual or entity to first complete a change of operator application.

Declares the General Assembly's intent to require full and complete disclosure and transparency with respect to the ownership, operation, and management of licensed nursing homes in Ohio.

Program & Service Update

Home Care Director Dawn Weber and Aging and Health Director Jenn Westfall traveled to Washington DC in late April to attend the USAging Policy Conference. The two-day conference included updates on the federal budget and aging priorities as well as Capitol Hill visits with Congressman Balderson and the staffers with Congressman Johnson, Senator Brown, Senator Vance and Congressman Wenstrup teams.

Aging Staff | Will be attending professional development training in Kansas City, Missouri in the month of June. The team will learn about the latest updates and abilities of the WellSky SAMs software system. This software system is used to monitor and track Older American Act funding for the agency and providers.

CURRENT INITIATIVES

HEAP Outreach | Regular Program outreach is occurring with weekly social media posts through the end of May. HEAP Summer Crisis begins in July, but we are still awaiting a new budget to start planning outreach. There is a training and update call with the state scheduled for June 6.

Aging Outreach | Spring outreach events are underway, recently staff attended the Senior Resource Day on May 11, the O'Neill Center Health Fair on May 12, and Senior Advocacy Group on May 23. Upcoming Events:

Medicare Outreach | General Medicare posts and information on Extra Help, Medicare Savings Programs, and Preventative Services run on a weekly basis across our social media channels. Pharmacy bags with Medicare information and advertising are being distributed in six of our eight counties.

Government Social Media Conference | The communications team attended the Government Social Media Conference in Reno, Nevada, May 2-4. The largest government communications conference of its kind, it gave our team the opportunity to hear from and meet with representatives with platforms including HootSuite, NextDoor, LinkedIn, Meta, and more. We also gained several valuable resources and templates for the council to use in developing and updating our crisis and emergency communications plans, the ADA accessibility of our website and communications resources, and best practices in adhering to First Amendment and open government standards.

Aging Summit | The events planning committee hosted our Aging Summit: Aging in Today's Appalachia on May 10 in the Buckeye Hills Conference Room. Global Meals and Public Partnerships sponsored the event, which is presented in partnership with the Buckeye Hills Foundation. Around 30 partners and staff attended and provided positive, constructive feedback on the content and ideas for the 2024 summit.

Broadband Listening Sessions | Working with Program Manager Ryan Collins, the Communications Director is working with media outlets across Southeast Ohio to promote our series of ten Broadband Listening Sessions May 30 through June 22.

State of the Region Conference | The Communications Director served on the planning committee for the 11th Annual State of the Region Conference, which took place at Ohio University on May 23. The Comms Director facilitated active roles in the conference for our staff, from moderating panels to presenting at the May 22 roundtable discussion with leadership from the Appalachian Regional Commission and U.S. Economic Development Administration. The conference itself had record attendance of more than 300.

Department of Energy Funding Opportunities | On February 13, the US Department of Energy (DOE), the US Department of Treasury, and the Internal Revenue Service (IRS) <u>announced</u> new opportunities available through the Bipartisan Infrastructure Law and Inflation Reduction Act:

- DOE's <u>Advanced Energy Manufacturing and Recycling Grant Program</u> (40209) is investing \$750 million to accelerate clean energy manufacturing in coal communities across the country.
- The <u>Qualifying Advanced Energy Project Credit</u> Program (48C) provides \$10 billion in tax credits to
 qualifying investments in clean energy technology manufacturing and recycling; industrial greenhouse
 gas emissions reductions; or critical minerals processing, refining, and recycling. Under the Inflation
 Reduction Act, at least \$4 billion in credits are set aside for projects in communities with closed coal
 mines or retired coal-fired power plants.

DOE Removes Match Requirements and Streamlines Application Process to Ensure Rural and Remote Communities Benefit from New Funding | The U.S. Department of Energy (DOE) announced \$50 million in new grant funding made available by the Bipartisan Infrastructure Law for community-based energy projects located in rural and remote areas across the country. The Energy Improvements in Rural or Remote Areas (ERA) Program allows for grant funding for community-based projects between \$500,000-\$5 million. This funding requires no cost share from recipients and projects funded will improve the cost, reliability, environmental impact, and climate resilience of energy systems in rural or remote areas with 10,000 or fewer inhabitants. Pre-Application Submission Deadline is July 13, 2023.

 meeting with GOA and Planners weekly. Buckeye Hills received notice on May 11th that all five Small
 Government applications submitted to OPWC to compete statewide, were funded. Fiscal Year 2025
 (Round 38) applications are due to Buckeye Hills on September 1st. The kickoff for Fiscal Year 2024 (Round
 18) Clean Ohio-NRAC funding took place also on May 11th and applications are due on September 29th.
- **Brad Peoples** has been working on the formation of OneOhio Region 12's proprietary scoring criteria. There are challenges associated with this, but he's confident that the Region 12 group is going to form impactful, practical scoring criteria that could have lifechanging effects to those suffering from a lack of recovery services and programs currently available in these communities.
- Jada Riley has spent time preparing to moderate the Revitalizing Downtown Districts panel at the 11th Annual Appalachian Ohio State of the Region, which was held on May 23rd. She has also been coordinating with area venues to have them complete Americans for the Arts' Organizational Survey as a component of the Arts & Economic Prosperity 6 Impact Study.
- **Emma Yeager** has been gearing up for our 10 upcoming broadband listening sessions over the next month. She has also been working with Ryan to score ARC projects.

NEWS

Program & Service Updates

Specialized Transportation 5310 In and Out of County Non-Emergency Medical Contracts | \$8,839.29 of the non-emergency medical transportation has been spent in Washington and Monroe counties for the first quarter.

USEPA Brownfield Assessment Grant | BHRC has requested project submission of former brownfield sites in the region. The Planning Division will now start the review and approval process for each site submission.

Regional Coordinated Plan for Transportation | BHRC and RLS will begin to work with the mobility managers in the region to develop the governing body for the regional coordinated plan.

Staff Updates

- Kate Dunn has been working on Noble Demolition Projects, and they have gone out to bid. The bid due date is June 7th at 9am, and the bid opening will happen at 11am that day at the Noble County Commissioner's Office. The Noble Remediation projects in Caldwell and Summerfield are well underway. RISE Ohio projects are also well underway with at least one project having been identified in each county. The USEPA Brownfields project intake has closed, and the review process has begun. This process will determine which projects go forward to participate in the grant.
- **Keegan Gault** attended the Ohio Basic Economic Development Course in Dublin with others from the Development Division. He attended a few brownfield & opening bid meetings with Kate to get a better understanding of those topics. He also met with consultants from American Structurepoint and representatives from Logan for a downtown Logan Strategic Plan kickoff meeting. He met with Tony Lang from Warren Water to obtain some of their waterline data to update their project mapping. He is representing BHRC on the Meigs County Hazard Mitigation Steering Committee and attended the first meeting to update the county's Hazard Mitigation Plan. Finally, he attended the Mayor's Partnership for Progress meeting in Athens and connected with some of the GIS specialists from Ohio University they work with.
- Melissa Zoller has been working with ODOT and RLS to create a regional plan, and the first steps will be discussed during the June meeting. ODOT District 10 office held local meetings in each of the counties, and I was able to attend the Noble County meeting. I have been working with Kate to develop bid packets for the Noble County Demo projects. She attended the ODOT 5310 conference in Toledo on May 23rd & 24th and attended the Planner check-in meeting for the Appalachian Community Grant Program. She worked with County Engineer Amy Zwick to secure funding for County Road 26 in the amount of \$1.5 million.
- **Kelly Isaly** attended Region 8 meeting at BHRC in regard to a Regional Coordinated Plan that will be coordinated by BHRC, the Monroe County Transportation Advisory Committee meeting on May 17th and the Noble County Health Department meeting to discuss her role in the County. County, advertising, and assisting in the preparation of surveys to be distributed in June. She provides on-going support in working with Morgan County for the Monroe County Public Transit programming and participates in various on-going committee calls.

• Julia Hinzman attended the Region 8 meeting at BHRC regarding a Regional Coordinated Plan that will be coordinated by BHRC, continued to work with ODOT committees, the New Mobility Manager group, a Welcome Committee, & Google Committee bi-monthly. She held the Noble Transportation Advisory Committee meeting to review county goals and upcoming projects. She will be presenting Mobility Management at the Family and Children's First meeting in Caldwell and met with the Noble County Commissioners to discuss Mobility Management and what is being done in the community. She attended the ODOT 5310 conference in Toledo on May 23rd & 24th and continues participation with the Belpre Transit Study group for extended transit services into Belpre. Currently, WWW Interstate Planning Committee is leading the study as a continuation of Parkersburg Area Transit, and they will be the provider into Belpre with Fixed Route and Paratransit. A public meeting was held May 4, 2023. She continued outreach visits to Washington and Noble Counties, distributing pamphlets and flyers. The surveys for Noble County will be ready for distribution in the community by mid-June and will be collected by mid-August.

- BroadbandOhio Digital Inclusion Pilot Projects Applications due June 16 | Ohio is participating in the State Digital Equity Planning Grant Program, a federally funded grant, to develop a statewide plan for achieving digital equity goals and closing the digital divide. Ohio's Digital Equity Plan will serve all Ohioans with an aim to promote meaningful adoption and use of high-speed internet service, with a special emphasis on key populations. As part of this planning process, BroadbandOhio is granting funds for Digital Inclusion Pilot Projects to organizations supporting digital inclusion efforts across the state. Digital inclusion efforts provide Ohioans access to:
 - Reliable, affordable, high-speed internet;
 - O Computers and other devices to meet users' online needs; and
 - Digital skills training and technical support.

These efforts help ensure every Ohioan has the technology, skills, and resources needed to fully engage in their communities, seek and often maintain employment, better connect with loved ones, learn, and access healthcare and other essential services. CURRENT INITIATIVES

• The Ridges | The Master Plan has been completed and the final report filed with ARC for the planning grant BHRC applied for to support the project. The Athens 317 Board has reached a tentative agreement with Ohio University to transfer a small section of land to expand their operations adjacent to the property. Community stakeholders and Ohio University representatives continue to work on the language for the conservation easement. The

Purchase Agreement has been signed by the Developer (Buckeye Hills Foundation and Community Building Partners) and Ohio University. The petition to create the New Community Authority has been filed with the Athens City Council. On June 15, 2023, a work session with Ohio University and the City of Athens and the Developer will be held to finalize details and revisions as the ongoing discussions and feedback have occurred throughout the 30-day period. Once that is completed, the Ohio University Board of Trustees will meet and approve the request to go to the Department of Administrative Services and request them to prepare a package for the State Controlling Board to approve the transfer of land. The Athens City Council will also place the matter up for consideration and hopefully approval on their agenda as well. The target is to have all approvals and have a deed, all New Community Authority, Tax Incremental Financing, and Community Reinvestment Act structures in place, and be open to investment in Q4 of 2023.

Appalachian Community Grant Program Updates | Planners continue to work with our communities and
partners to gain knowledge and refine their projects. In several cases, the projects are not well suited to this
program and those are beginning to be identified and redirected to other programming. We are hopeful that not
only will we garner large investment in the BHRC area for this program but also investment from other programs
as well now that effective projects have been scoped.

FEDERAL UPDATES

- USDA Announces Rural Community Development Initiative Grants due June 28 | U.S. Department of Agriculture (USDA) Rural Development recently announced they are accepting applications for grants that will improve housing, community facilities, and community and economic development projects in rural areas around the country. USDA is making the grants available under the Rural Community Development Initiative. The program provides grants to organizations that will provide financial and technical assistance for housing, community facilities, or community and economic development projects. Grants may be used to train subgrantees to conduct educational training on homeownership or minority-owned business entrepreneurship. They also may be used to provide technical assistance to sub-grantees on:
 - o strategic plan development
 - o accessing alternative funding sources
 - training and resources for board operations, management, financial systems and information technology
