# Vibrant Communities Grant Program (VCP)

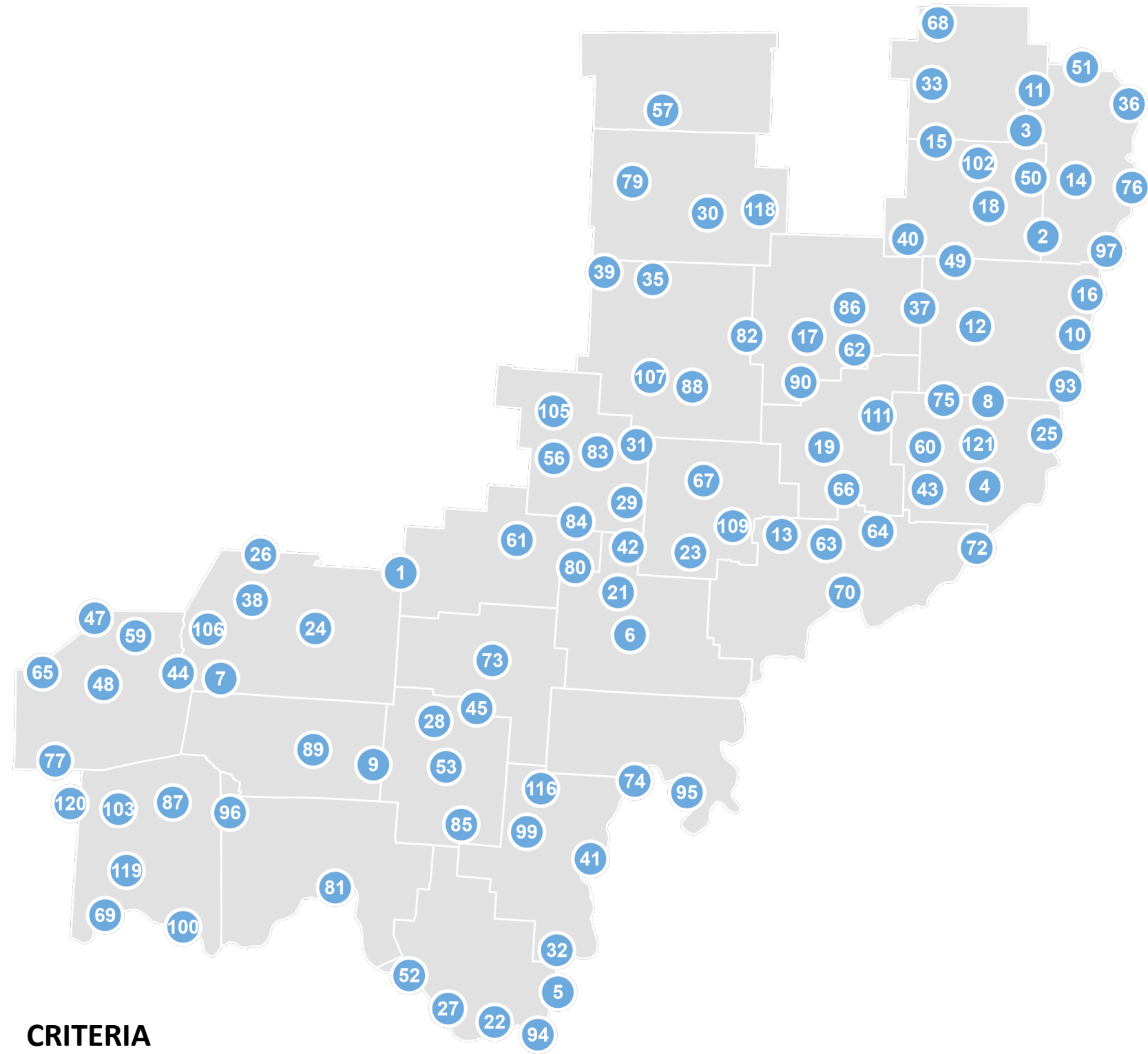
## Changes now in effect:

- Expansion of the JobsOhio Vibrant Community program to eligible municipalities (based on poverty rate) to include smaller communities. This change takes eligible communities in the Southeast Ohio region from **13** to **123**.
- The maximum award is now \$1 million, not \$2 million. This is an effort to include more eligible projects and increase impact.
- The eligible applicant will now be the community, Port Authority or CIC. The developer can be the beneficiary of grant funds, but the community will be actively involved in developing and supporting the project to bring it to fruition.
