PASSPORT Program

The PASSPORT Program is Ohio's alternative to nursing home care. It helps disabled older adults remain safe and independent at home.

The PASSPORT Program offers a cost-effective, in-home alternative to nursing home care for Ohio residents age 60 and older with long-term care needs. PASSPORT is an Ohio Medicaid waiver program.

Services in this program may include:

- Personal Care
- Homemaker Services
- Home Medical Equipment
- Respite Care
- Home Delivered Meals
- Nutrition Counseling
- Adult Day Services
- Minor Home Modifications
- Emergency Response System
- Transportation to Medical Appointments
- Waiver Nursing
- Consumer Direction
- Homecare Attendant Service

How the PASSPORT Program works

A referral to the PASSPORT program may come from anyone. To get started, simply call 1-800-331-2644.

A PASSPORT assessor will visit the individual's home to evaluate the individual's in-home needs and determine whether they meet eligibility requirements.

The care manager and individual will work together to coordinate services to meet the identified needs.

A care plan will be created to help the individual remain at home.

PASSPORT Program Eligibility

Must be age 60+ at the time of enrollment

Must meet Medicaid financial eligibility

Must need hands-on help with daily activities such as bathing, dressing, and meals

Must agree to the service/care plan

Service needs cannot be met by other available community resources

Health related needs can be safely met in the home setting

Service plan must be approved and signed by the individual's physician
