OAA Overview

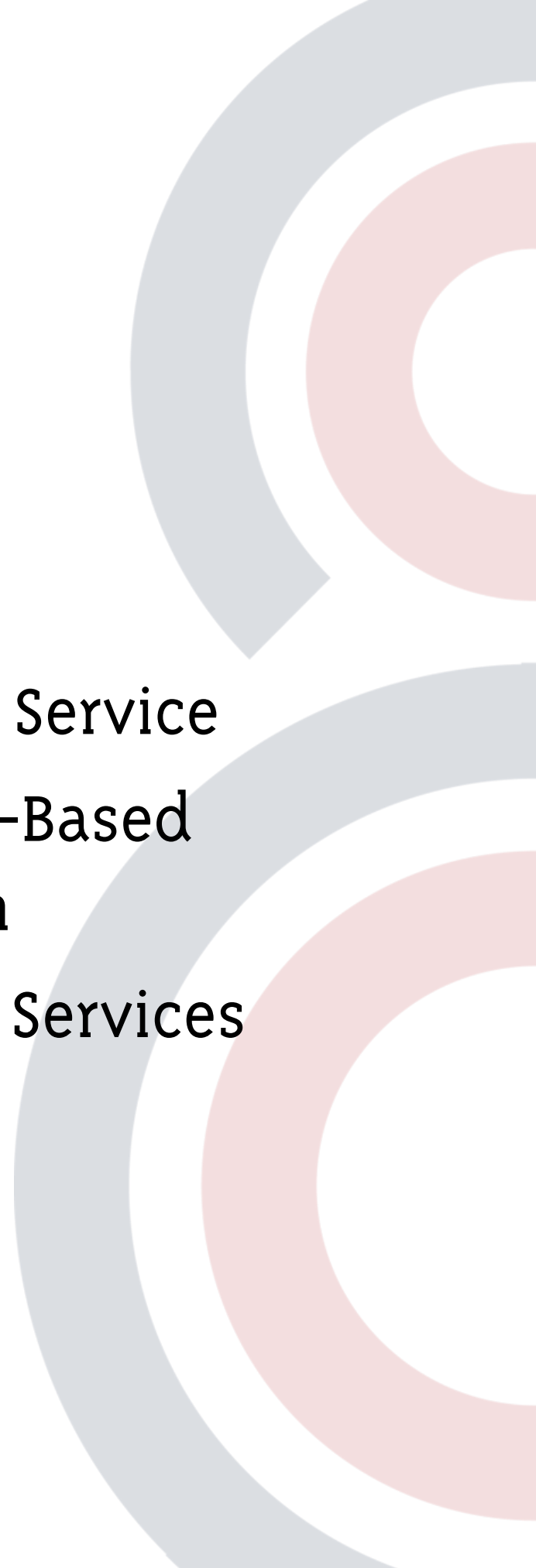
The OAA was established to deliver supportive services to older adults throughout the United States and our eight-county region.

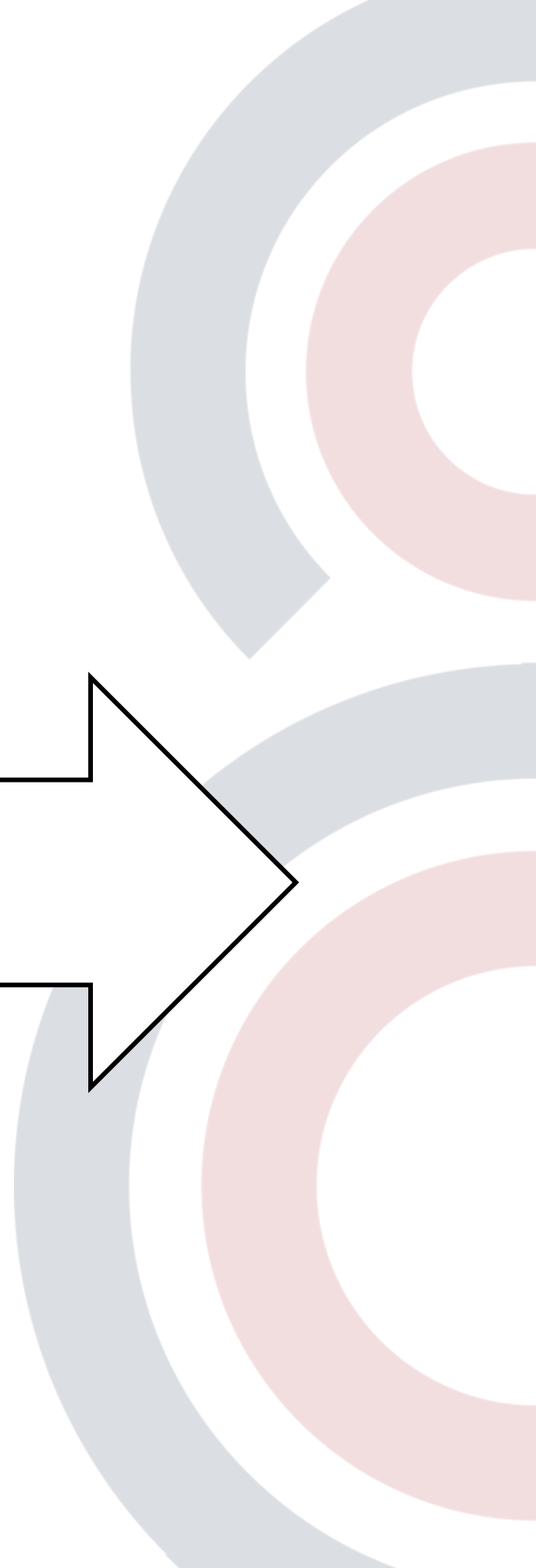
Provider Requirements

Budget and Budget Sheets

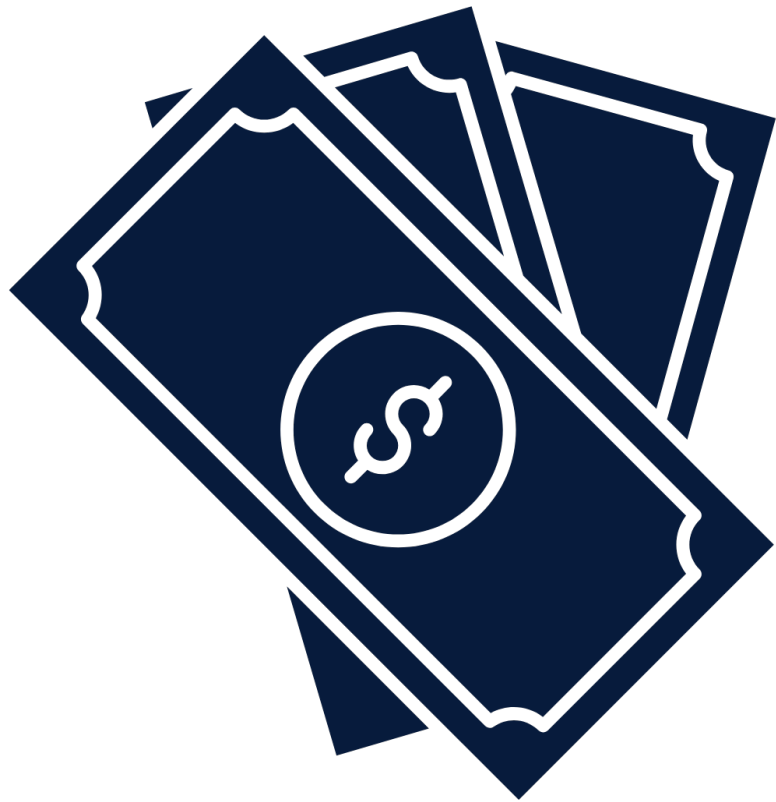
- Interstate Funding Formula (IFF)
 - ODA is currently re-formulating the IFF.
 - When final budgets are received; providers will be updated.
 - At this time, BHRC is using last years funding levels for budgets.
 - Budget sheets will be available on the BHRC RFP page at buckeyehills.org/rfp after the bidders conference.



- Matching Funds Requirements:
 - Title III C1/C2 15% Match Requirement
 - Title III B 15% Match Requirement
 - Title III D No Match Requirement
 - Title III E 25% Match Requirement

Budget and Budget Sheets

The following is an example of how to correctly calculate the required match.
This calculation is to be used to determine Required Match Funding for all services.



Older American's Act funding requested	\$10,000.00
Divide OAA requested funding by 85% (.85)	<u>÷ 85% (.85)</u>
	\$11,764.71
Total amount of service to be delivered	\$11,764.71
Subtract OAA funding requested	<u>-\$10,000.00</u>
Amount of Match Funding required	\$ 1,764.71

Contracts

- Contracts will be sent for signature in late November.
- Contracts will be fully executed prior to January 1, 2026.



For the 2026 and 2027 RFP cycle, contracting will be for each calendar year.

This will result in each provider having separate contracts for each calendar year.

Contracts will run Jan. 1, 2026- Dec. 31, 2026, and Jan. 1, 2027 to Dec. 31, 2027

**Funding estimates will be equal for each year
(dependent on final numbers from the Ohio Department of Aging).**
